## SPONSORED LEGISLATION



AB 2746 (E. Garcia)

This proposal will specifically add internet tax sale language into the current code and the reference to commencement and conclusion of the tax sale after the final right of redemption.

\*we are technically support due to timing.



# SB 1506 (Sen. Gov and Finance)

This proposal adds language into the current code to affirm the required notifications to property owners of tax defaulted properties are not in violation of the automatic stay when a property owner files for bankruptcy. Also, provide due process by notifying property tax owners of tax defaulted status that are also in bankruptcy.



**AB 2558 (Brough)** 

This proposal states that local office consolidations would only be authorized through a vote of the people.



This proposal will allow agencies access to "AA-AAA" rated securities that are currently ineligible for purchase due to the originating issuer rating being below the minimum "A" rating, and also clear up any ambiguity over the application of the five-year tenor limit to securities authorized under this section.



### **Other Legislation of Interest**



AB 2458 (Weber) requires that TTCs include parcel tax exemption information on the tax bill and on the TTC website.

CACTTC is opposed and has asked for amends to shift this aggregation to the County Office of Education.

#### Homelessness Funding

 Funding proposals pending in the Legislature t range from \$1.5 billion to \$5 billion over four years. The May Revise Budget also contains more than \$350 million in one-time spending with \$250 million earmarked for Homelessness Emergency Aid block grants targeted at local governments.

- Asm. Mayes (SB) less votes than 1 of his challenges (D).
- Asm. Cervantes (Riverside) less vote than her one challenger (D)
